On 13th February, 2024, the Ministry of Commerce ("**MOC**") issued its Notification No. 1/2024 to specify the rates of the official fees in Myanmar Kyat ("**MMK**") for filing applications in relation to copyrights matters under the Myanmar Copyrights Law 2019 ("**CRL 2019**") effective from 13th February 2024. We summarized the types of the applications and the official fee rates in the table below.
